If not accepted, exhibitor will be notified and the application fee returned at once. Exhibits must be ORIGINAL / HANDCRAFTED BY THE ARTIST. Booth Reservation: All Booth spaces are outside, approximately 10' x 10'. The Arts Alliance will host an artists' hospitality area for your enjoyment. Booth sitters are available during the event. You are responsible for promoting your own work.

One Artist Fee = \$75 2 Artists per Booth = \$100 (maximum 2 artists per booth)

Artist's check-in and set-up is **between 6:00 am and 8:00 am** on Gamble Avenue on Saturday morning.

Art in the Park committee will award Best of Show to the artist that the judges score highest overall. We will award 1st Place, 2nd Place and 3rd Place ribbons in each of the nine categories. Only original artwork will be judged. **Plan to submit one item the day of the show per your category above. Please bring the item to the judging area by 8:30 am.**
